

## ZIMBABWE POVERTY DATUM LINE UPDATE - JANUARY 2021



- According to ZimStat, the per capita cost of living, as measured by The Total Consumption Poverty Line 'TCPL' increased by 6.8% in January 2021 to ZWL\$4,987, from ZWL\$4,670 recorded in December 2020 - Graph 1. The major cost push factors emanated from fuel and gas price hike, public transport fare adjustments and increases in prices of other basic commodities. The recent upward review of toll fees in ZW\$ will further exert pressure on prices up stream going forward.
- The data also showed that during the month of January 2021, the largest increase in cost of living was recorded in Manicaland (9.7%), Mash East (8.2%), Mat North (8.2%) and Masvingo (7.5%). However, Mash Central, Bulawayo and Mat North remained the most expensive province in the country, requiring an income of ZWL\$5,650, ZWL\$5,503 and ZWL\$5,295 per month for one person, respectively- **Graph 2.**
- Meanwhile, ZimStat advised that, in line with international standards of disseminating poverty statistics, the agency has, with effect from November 2020, discontinued the publication of provide poverty lines for a standard family of five, and will only disseminate the Food Poverty Line "FPL" and TCPL for one person.
